- 1. Both parents/legal guardians are obligated to pay the school fees, as set out by the School Governing Body.
- 2. Please Note: The Education Law states that school fees are compulsory for public schools. By letting your child attend school at Swellendam Primary School, both parents/guardians accept responsibility for school fees, regardless of who entered the learner into the school.
- 3. Registration fees (a first payment) should preferably be made directly after admission. This serves as a first payment of the compulsory school fees.
- 4. It is the responsibility of the parents to ensure payment is received by the school before or on the payment deadline.
- 5. School fees are paid monthly in advance, across a period of 11 months from January to November.
- 6.If the school is forced to hand over school fee debts to lawyers for collection from parents/guardians, said parents/guardians are liable for any lawyer and client fees that might arise from the collection of these debts, as well as any collection commission.
- 7. Parents/guardians who cannot afford the school fees, may apply for partial or full exemption of school fees at the School Governing Body. The procedures for applying for full or partial exemption of school fees, were discussed and accepted by the majority of parents at the budget meeting. The procedures and application forms are available on request at Mrs R. Cronje. The closing date for exemption for new learners is the last school day of January. No exemption will be given for Grade R learners.
